

Camper Orientation will be held on Tuesday, July 11, 2023 at the Garrard County Extension Office. The program will begin promptly at 6:00 p.m. so we ask you to arrive early to register and complete any missing paperwork. All campers and at least one parent/guardian should attend.



Departure Day - Monday, July 17th, 2023

All campers should report to the registration tables at the Garrard County Extension Office—NOT BEFORE 7:45 a.m. and NO LATER than 8:15 a.m. on Monday, July 17th, 2023. The buses will leave promptly at 8:45 and any late arrivals will have to be responsible for getting to camp on their own. Maps can be obtained at the Garrard County Extension Office.

Check-in Procedure: Register, receive a nametag, check-in medication and go to the lice check station. At the lice check station, the camper will receive a bracelet that allows them to get on the bus, then drop off your luggage. When the buses arrive, we will start loading.



RETURN DAY-FRIDAY, JULY 215T, 2023

PHOTO ID WILL BE REQUIRED TO PICK UP A CHILD.

Due to the change, it is very important the you have completed the pick up and release form. Only the persons listed on the form will be allowed to pick up the camper. Campers will be dismissed from the bus. Parents/Pick-up person will need to show a photo ID at the bus and sign a check-out form.

The buses will arrive back in Lancaster at the Parking Lot of the Garrard County Extension Office at approximately 12:00-12:15. on Friday. Please be prompt in picking up your child. It is very scary for kids when everyone else has been picked up and they are still waiting! In the event of an emergency that will make you late, please contact Eric Comley at eric.comley@uky.edu.

Before leaving the parking lot, don't forget to pick up all of your child's luggage as well as medicine. Anything left at the Garrard County Extension Office will be held until the Wednesday after returning from camp. After that any medicine will be properly disposed and clothes, towels, etc. will be donated to Goodwill.

CAMP DRESS CODE

Items that should NOT be worn during 4-H camp by leaders or campers

- Halter Tops
- Shirts with spaghetti straps (unless a shirt with sleeves is worn at all times to cover it)
- T-shirts that have profanity, sexual innuendos, violence, obscenities, racial/gang overtones, or advertise beer, liquor, or tobacco products
- No bare mid-riffs
- Tattoos that may be viewed as inappropriate should be covered
- Swim wear should be covered by a t-shirt when out of the pool
- Shorts must be appropriate (approx. tip of middle finger length down the thigh)
- No string bikinis
- At no time should underwear be visible

Any camper or leader whose clothing is considered to revealing (too short, too low, too tight, etc.) will be asked to change

Hint— If you are unsure if something is appropriate, you should probably not wear it!

DO NOT BRING...

We do not recommend that a camper bring anything valuable to camp. Radios and CD players, cell phones, personal head sets, and portable video games will be collected and returned to the parents on return day. Expensive cameras are not recommended. Disposable cameras are best for camp, remember to label with your child's name.

PACKING-WHAT AND HOW!

- Casual clothes (shorts, t-shirts, etc.)—1 set per day and 1 extra set
- Pajamas or other sleeping clothes
- Twin sheets and blanket (or sleeping bag) and pillow
- Towels and washcloths (send old ones)
- · Beach towel for swimming
- One piece bathing suit or swimming trunks
- 2 pairs of comfortable walking shoes—flip flops can only be worn to the pool and to the shower house.
- Sandals must have a back across the ankle to be permitted.
- · Light rain jacket or poncho
- Soap, deodorant, shampoo, toothpaste, and toothbrush and a caddy to carry them in
- Sunscreen and bug spray

Please label your child's luggage and bedroll/sleeping bag with their full name. We recommend using colorful tape or ribbon so it will be easy for them to identify at camp. They are responsible for identifying their own luggage and carrying it to their cabin. Clothes and other items should be packed in a durable suitcase or duffle bag. Bed

Clothes and other items should be packed in a durable suitcase or duffle bag. Bed rolls/sleeping bags can be packed in a garbage bag, please remember to pack an extra bag in your campers suitcase for the trip home!

HOME SICKNESS

Please discuss with your child about being away from home (especially if it is their first time!) We cannot allow every child to "phone home" at the first twinge of home sickness. The phone is used only for emergencies. We work with homesick children by helping them stay very busy and receive special attention from the leaders. Do not tell your child if they get lonely to just call home. Instead send them with a special teddy bear or item of comfort. If after our best efforts are made, your child remains homesick, you will be contacted. We will not make a homesick child stay at camp—however, no refund can be given. Please assist us with this matter by talking to your child before they leave for camp!

Bedwetting

If your child has a bed wetting problem, please send extra sheets. If you have not already notified us of this on the registration form, please let us know before we leave for camp.





MEDICATION

If your child has medication that he/she is required to take each day, the medication is checked in with the EMT and administered by the EMT each day. Please turn in your child's medication (in the original container) on Monday morning in a Ziploc bag with your child's name written on the outside of the bag plus a photograph of the child is now required. You must also complete the medication form that is attached to this newsletter and enclose it in the Ziploc bag. The EMT will administer the medication while at camp, so NO medicine is stored in cabins. This procedure is necessary for the safety and protection of your child. Please do not send over the counter medication, because it will also have to be checked in with the EMT. If your child needs over the counter medication and you have given your permission it will be administered by the EMT. If you did not give permission and your child becomes ill, you will be contacted.

SPECIAL NOTE: If your child is on any antidepressant and/or hyperactivity medicine (ex. Ritalin) during the school year, please make sure they are on the medication during summer camp. Help your child have a GOOD week

HEAD LICE

No need to panic, but please check your child for possible evidence of head lice before leaving for camp. There is a no tolerance policy for head lice. In the event that it is found at the lice check station on departure date, your child WILL NOT be able to board the bus and will not be able to attend camp! Not even after a visit to the doctor! Please keep this in mind and if you have any suspicions that your child may have lice, please take care of it prior to camp departure date.

CELL PHONES
